



## **Covid-19 Response: A Statement from the Denominational Leaders of the Kentucky Council of Churches**

*"No, in all these things we are more than conquerors through him who loved us. For I am convinced that neither death nor life, neither angels nor demons, neither the present nor the future, nor any powers, **39** neither height nor depth, nor anything else in all creation, will be able to separate us from the love of God that is in Christ Jesus our Lord." --Romans 8:37-39*

Governor Beshear and members of the Kentucky Covid-19 response team met with Kentucky Council of Churches Executive Director, Rev. Dr. Donald K. Gillett, II, council president, Rev. Kent Gilbert, and judicatory leaders or representatives from all member communions of the Council in a special conference call Wednesday evening.

On Wednesday morning, March 11, the governor issued guidance that houses of worship consider cancelling services for this and possibly succeeding weeks. Presentations in our meeting by Gov. Beshear and Dr. Steven Stack, Kentucky Commissioner for Public Health and former president of the AMA, outlined the special concern for any gathering where droplet transmission could be increased. Churches are such places, and often populated by those most at risk.

"I know it is a big step, but I can tell you the direct connection between at least two Harrison County residents is that they go to church together," Gov. Beshear said according to an article in the Lexington Herald-Leader. "We would not be suggesting" that these services should be canceled "if we did not believe this coronavirus can be or is currently being spread in those areas."

With the Covid-19 task force, the bishops, conference ministers, and denominational representatives of the KCC meeting affirm that protection of the most vulnerable and the care of our neighbor is a primary goal as we navigate this world-wide pandemic.

We commend the Governor for his transparent and assertive caution to slow the spread of the virus and to keep Kentuckians informed. We join him in urging every congregation to actively engage in efforts to reduce the risk of infection as appropriate to each church and denominational setting, whether curtailing services and activities or by making them as safe as possible for participants.

The Governor and Covid19 task force are recommending the following best practices and urge churches to take seriously their vital role as leaders for health:

- Large gatherings of people should be cancelled, postponed, or done virtually in order to the community spread of COVID-19 to the most vulnerable people; those over the age of 60, and those with underlying health issues, including someone with diabetes, heart, lung and kidney disease.
- Vocal choirs are of particular concern because of close proximity and droplet contamination from singing. Churches who do not cancel services should consider suspending rehearsals or limiting participation. Two of the Harrison County, KY infections were likely transmitted by church choir rehearsal exposure.

- For those congregations who choose to remain open, the KCC along with the governor's task force recommends following the CDC protocols for "social distancing" and proper hygiene procedures. Some of these include encouraging those over 60 to stay home, altering greetings and church ritual to avoid as much droplet contamination as possible, and to keep a physical distance of 6 feet whenever possible. We welcome this chance to keep our congregations and all of Kentucky informed and knowledgeable. We will be actively and regularly sharing information to constituent member bodies as conditions evolve. Those with questions may contact Rev. Dr. Gillett who will act as conduit for the KCC.

While we affirm that not every recommendation may be possible for every congregation, we know that *inaction* is neither faithful nor wise. As we remember that the heart of Christian ministry is service to and love of our neighbor, so too we remember that every act to prevent the spread of disease is an expression of that holy discipline. If in this season we must change our ways for the sake of our neighbor's health, then as Paul reminds us in Romans, "in these things we are more than conquerors... for nothing shall separate us from the love of God in Christ Jesus."
